This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

### Section 6 - Accidental Release Measures

**Personal Precautions:** Approved respirator to AS1715 to be worn, gloves, safety glasses and protective overalls.
